- b. How do we fund operations going forward?
 - a. Legislation
 - i. Would like to start by sitting with 3 from this area on Zoom call, to discuss our needs. Do we know why the Kenai keeps being passed over in terms of funding?
 - ii. Why is KP being passed over? Love INC did not receive what it requested from the legislature. Shelter received from borough the health equity grant 2 years ago. One renewal since then.

- d. CPH, SPH, Prov Hospitals
 - i. Ask for funds from:
 - 1. AURORA INTEGRATED ONCOLOGY FOUNDATION (operating funds for the shelter Kathy to request)
 - 2. SOLDOTNA ROTARY (Kathy to ask when next opening would be)
 - 3. Leslie learned how one hospital became involved. At first hospital admin was concerned support would affect billable hours to Medicaid. Went to ER doctors, who said that hospital needs to support some sort of housing or respite housing for when people are discharged. College could offer residential units, request would be better received from hospital.
 - a. HAPP funding and special needs funding are funded by MH trust. When they put in their request, they ask for an extra \$5M every year that is denied. That would be disbursed among providers on the Kenai. If the MH trust were granted that request. At one point housing budget was swiped, which would have closed all shelters and services. People pushed back and it was reinstated. However, it is flat-funded which constitutes a decrease.
 - Does emergency cold weather shelter fall outside of that limited bucket of hoped-for funds? Yes. Plan to in 2025 apply for Rasmuson for Legacy grant of \$2-2.5M. coordinate 100% community

 - a. Still a legal entity but all funds are transferred to Mountain Home Group. Tim to communicate in next meeting that any funding is for new projects and as of yet they have not secured funding to repay will ensure no interest at the least, however
